1. Objectives of MoU

- f. Exchange of research and educational materials, publications and academic information.
- g. Technical assistance.
- Creation and organizing credit and non-credit courses (including skill enhancement courses).

ACTIVITY AGREEMENTS

Before any activities may be implemented, the parties shall discuss the relevant issues to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the activity.

Activity agreements will include terms such as the following:

- 4. I laboration of the responsibilities of each impitution for the agreed upon activity.
- h. Specific schedules for the activity.
- Detailed management of intellectual property rights and publications.
- Any other items doesed necessary for the efficient management of the activity.

RENEWAL, TERMINATION AND AMENDMENT

- This MoU shall remain in force for a period of 3 (Three) years from the date of the lost agreement. This MoU may be extended by the written consent of the parties.
- 2. This MoU may be terminated anytime by either party, giving written notice to the other party at least two months prior to the stated termination date. Termination of this MoU shall not affect activities in progress pursuant to specific activity agreements, which shall continue until concluded by the parties in accordance with their terms or as otherwise agreed upon by the parties in writing.
- 3. This MoU may be amended only by the written consent of the parties.
